Health Commissioner's Perspective

2009 was the year that public health came through to protect the community from the H1N1 influenza virus. We have trained many years for such an outbreak; we educated the public, collaborated with partners and worked to secure financial support for vaccinating against H1N1. The health district is here to protect the residents of Preble County.

The Preble County General Health District is a blanket of protection for all who live, work and play in our county. Our programs improve the public's health through inspection, education, prevention, emergency response and advocacy. Many of the health district's services are not always apparent to the public and the better we do our job, the safer food and water are, disease incidence remains low, and service is accessible to county residents.

DIVISION OF HEALTH INFORMATION AND EDUCATION

The Health Information and Education Division is a source of valuable and critical information to assist people with living healthier lives. This information encompasses a myriad of topics including tips on a healthy lifestyle, injury and disease prevention, emergency communications, current health events and much more. Information about Preble County General Health District's programs, downloadable forms and timely information can be found at the newly redesigned website: <u>www.pcghd.net</u>. Additionally, this web portal was recently used to collect data about Influenza-like Illnesses in school systems and doctors offices. In the future, it will be used to collect information pertaining to the opinions, wants and needs of the residents of Preble County.

Emergency Preparedness/Epidemiology

The health district responds to adverse events that occur locally and coordinates health district emergency response activities with local and regional emergency planners and responders. The health district works in tandem with our partners to provide the necessary coordinated efforts that would be needed to protect the health of the community during any disaster. The health district collaborated with local and regional public health response partners in response to H1N1 public health emergency and conducted mass H1N1 vaccination clinics. During the emergency response period, Community Emergency Response Team (CERT) and Medical Reserve Corps (MRC) volunteers provided medical and non-medical support at the mass vaccination clinics.

Epidemiological surveillance program monitors over-the-counter medicine sales, local hospital emergency room visits, school and outpatient influenza activities, and communicable disease. Epidemiological surveillance program implemented a web-based school and outpatient influenza surveillance program in 2009 and has worked closely with schools and healthcare providers to monitor influenza activities in the community.



The Preble County General Health District is the provider of service for the Help Me Grow program which focuses on the health and development of children birth to three years. This **voluntary** program offers free home visits to parents in Preble County and provides information in child development, safety, and community resources. HMG serves expectant parents, newborns, infants, toddlers, and provides ongoing support for the continuing challenges of parenting. HMG assists with early identification of children with developmental concerns or disabilities and works closely with various providers to offer early intervention services. HMG supports parents as full partners in their child's social and emotional development, laying the foundation for later school success.

The Health District is responsible for registering plumbing contractors, issuing permits, inspecting new and altered plumbing systems and educating plumbers on state code requirements. Bacterial pathogens, parasites, viruses, and chemical contaminants are all potential causes of water borne diseases that can affect human health.

NURSING DIVISION 2009

Public health nurses provide services throughout the county to assess, protect, and promote the health and well being of our residents. This is accomplished through the provision of direct client services, population based screening, education, and health promotion activities.

Child and Family Health Services

Assessments and screenings are performed on clients birth to age 6 years, with an emphasis on health promotion and preventative health practices. The clinic is based on a sliding fee scale for services.
